**B. Non Emergencies – Dial 933-4444**

1. When an officer is needed at the scene but the situation is not life threatening.
  - a. Loud Music
  - b. Neighbor trouble (non-violent)

**C. District Notifications – Dial 935-7252 (5<sup>th</sup> District)**

1. Non-emergencies when a squad is not needed.
  - a. FAX number 935-7115 (Hot spot forms or drug complaint forms)
